General Guidelines for Artwork

- 1. Provide one digital file of your logo in color, on a white background.
- 2. All required registered, trademarks and service marks must be part of the logo artwork.
- 3. Color must be applied directly to the digital art file.
- 4. A copy of your logo on a white background should be provided, along with color specifications (Pantone® matching colors), when you send the digital logo file.

<u>Acceptable creator programs</u>: Mac or PC (Acceptable file formats: **EPS - preferred**, PSD, TIF, BMP and GIF)

- Adobe Photoshop-compatible (preferred and any format)
- Adobe Illustrator

<u>Unacceptable creator programs</u>: If your logo artwork only exists in the programs below, artwork should be submitted as camera-ready art measuring at least 4"x 8" on a white background. (Black and white camera-ready artwork along with the Pantone® color specifications will appear with more clear color than color camera-ready artwork)
