### What are the new dates for systems integration?

As announced in [Head Trader Alert #2006-114](#), NASDAQ® planned to begin the systems integration of NASDAQ, Brut and INET on Monday, August 28, 2006, with 20 NASDAQ-listed securities.

However, in order to give firms more time to complete the functional changes necessary to accommodate the integration of the NASDAQ Market Center®, INET and Brut, NASDAQ has moved the start date of the integration to September 18<sup>th</sup>.

The first integration phase, now scheduled for September 18<sup>th</sup>, will still consist of the previously announced 20 NASDAQ-listed securities. This list is available on the NASDAQ Trader® website in both [csv format](#) and [txt format](#). The remaining lists will be made available as soon as possible.
