Titan International, Inc. (TWI) has declared a 5 for 4 stock split payable to shareholders of record on Thursday, July 31, 2008. Distribution date for the stock split will be Friday, August 15, 2008. **Ex-distribution date for the stock split will be Monday, August 18, 2008.**

Position and Exercise Limits:

Position and exercise limits will change from 7,500,000 to 9,375,000 shares until the expiration date of Saturday, January 17, 2009.

Unadjusted New Shares:

New TWI series with a contract unit of 100 shares will be introduced on Tuesday, August 19, 2008 Strike prices and expiration months will be announced on a separate release.

Adjusted Exercise Prices:

Effective with the opening of business on Monday, August 18, 2008, trading in TWI series will be on an adjusted basis. The strike price adjustments below are expected based on the current outstanding series. Any additional TWI series added prior to the effective date will also be adjusted in the manner outlined below.
