NYMEX HOLDINGS INC (NMX) Pending Merger with CME GROUP INC (CME)

On Monday, August 18, 2008, the shareholders of Nymex Holdings Inc. (NMX) will vote to approve the proposed merger with Cme Group Inc. (CME). Pursuant to the merger terms, each NMX share will be converted as follows:

Stock Consideration: An amount of all outstanding NMX Common Shares will be converted into an amount of CME Common Shares per NMX share equal to \$36.00 cash plus the product of 0.1323 times the average CME share price, as described in the prospectus, divided by the average CME share price, subject to prorations. Cash will be paid in lieu of fractional CME shares.

Cash Consideration: An amount of all outstanding NMX Common Shares will be converted into an amount of cash per NMX share equal to \$36.00 cash plus the product of 0.1323 times the average CME share price, as described in the prospectus, subject to prorations.

Within the terms of the merger, NMX shareholders may choose one of the following:

Cash Election: Elect to receive cash for each NMX Common Share; OR

Stock Election: Elect to receive CME Common Shares for each NMX Common Share; OR

Mixed Election: Elect to receive a combination of stock and cash; OR

Non-Election: Register no preference by not making an election

All elections will be subject to prorations as described in the Proxy Statement. Electing NMX shareholders may receive cash, CME Common Shares or a combination of cash and stock; while non-electing NMX shareholders will be treated as cash electing shares (as described above).

ELECTION DEADLINE:

Elections must be submitted to the Exchange Agent prior to the election deadline, which is 5:00 p.m.,

Chicago time on Wednesday, August 20, 2008. NMX shares may **NOT** be delivered under "Notices of Guaranteed Delivery". Call option holders wishing to participate in the election must exercise their options at least three days in advance of the election deadline.

The merger is ANTICIPATED to become effective on Friday, August 22, 2008.

Pending Contract Adjustments

Pursuant to the by-laws of The Options Clearing Corporation ("OCC"), all Nymex Holdings Inc options will be adjusted as follows:

OPRA Option Symbol(s):	NJO becomes NJF NMX becomes NJE LXN becomes LON
No. Of Contracts :	Unchanged

Strike Prices: Unchanged
Multiplier: 100 (e.g. Premium of 1.00 = \$100)
New Deliverable/Contract: **The deliverable for adjusted NMX options will be based on the merger consideration which accrues to non-electing shareholders. The adjusted deliverable may be cash or a combination of cash and stock.**

GTC Order Cancellation:

Customers should be advised that all Good-til-Cancelled (GTC) orders not on AUTOM must be cancelled and re-entered prior to the ex-distribution or effective date. GTC AUTOM orders will be deleted by PHLX Service Desk/AUTOM personnel.

Position and Exercise Limits:

Position and exercise limits will be determined following the announcement of the final deliverable.

Adjusted Exercise Prices:

Effective with the opening of business, after the date the merger is consummated, trading in NMX will be on an adjusted basis. The strike price adjustments below are expected based on the current outstanding series.

Any additional NMX series added prior to the merger date will also be adjusted in the manner outlined below.
