SONUS PHARMACEUTICALS INC (SNUS) - MERGER - EFFECTIVE

On Tuesday, August 19, 2008, the shareholders of Sonus Pharmaceuticals Inc (SNUS) voted and approved the proposed merger with Oncogenex Pharmaceuticals Inc. (OGXI). Pursuant to the merger terms, each SNUS share will be converted into the right to receive .05556 OGXI Common Shares. Cash will be paid in lieu of fractional OGXI shares. The merger became effective on Wednesday, August 20, 2008
