Partial Self-Tender Offer

United Rentals, Inc. (URI) is offering to acquire up to 27,160,000 of its Common Shares, at a price of between \$22.00 and \$25.00 cash per share, in accordance with the terms and subject to the conditions set forth in the Offer to Purchase, dated June 17, 2008, and in the related Letter of Transmittal, which together constitute the "Offer".

There is a guarantee period of three (3) New York Stock Exchange Trading Days, in which shares not immediately available may be tendered under a "Notice of Guaranteed Delivery".

The Offer and withdrawal rights will expire at 5:00 P.M., New York City Time, on Wednesday, July 16, 2008, unless extended.

SPECIAL RISKS

Special risks exist for uncovered writers of URI call options. If an uncovered call option writer is assigned on or before the tender offer expiration date, the writer may not be able to deliver URI Common Stock by the option settlement date. The Options Clearing Corporation ("OCC") Article VI, Section 19 of the By-Laws describes steps, which may be taken in the event that there is a shortage of shares.

Please note that URI options will not be adjusted to reflect the expiration of the tender offer. Until a merger, consolidation or similar event occurs, URI common stock will still exist, trade and be deliverable in settlement of option exercise.
