On Thursday, December 20, 2007, the shareholders of Saifun Semiconductors Ltd. (SFUN) voted to approve the proposed merger with Spansion Inc. (SPSN). Pursuant to the merger terms each SFUN share will be converted into the right to receive 0.7238 SPSN Class A Common Stock, and approximately \$6.20 cash. Cash will be paid in lieu of fractional shares. The merger became effective on Tuesday, March 18, 2008.
