 Re: **Steel Dynamics, Inc. (RQL/STLD) - 2 for 1 Stock Split**

Steel Dynamics, Inc. (RQL/STLD) has declared a 2 for 1 stock split payable to share holders of record on Wednesday, March 19, 2008. Distribution date for the stock split will be Friday, March 28, 2008. **Ex-distribution date for the stock split will be Monday, March 31, 2008.**

The Options Clearing Corporation (OCC), pursuant to OCC By-Laws, intends to issue on the distribution date (1) additional RQL option contract for each option contract held. Further, on the ex-distribution date each RQL series will have an adjusted exercise (strike) price equal to 1/2 of the exercise (strike) price for each RQL series existing on the business day preceding the ex-distribution date. For example, beginning on Monday, March 31, 2008 an account holding (2) RQL APR 40 calls (RQL DH) will hold (4) RQL APR 20 calls (RQL DD). Customers should be advised that (1) contract in the adjusted RQL series will still represent 100 shares of STLD common shares.

POSITION/EXERCISE LIMITS:

Position and exercise limits will change from 500,000 to 1,000,000 contracts until the expiration date of January 16, 2010

GOOD-TILL-CANCELLED (GTC) ORDERS:

Customers should be advised that all Good-til-Cancelled (GTC) orders not on AUTOM must be cancelled and re-entered prior to the ex-distribution or effective date. GTC AUTOM orders will be deleted by PHLX Service Desk/AUTOM personnel.
