**\*\*UPDATE\*\* RENOVIS, INC. (RNVS) EFFECTIVE**

On Thursday, May 1, 2008, the shareholders of Renovis, Inc. (RNVS) voted to approve the proposed merger with Evotec AG (**EVTCV**). Each RNVS share will be converted into the right to receive 0.5271 **EVTCV** American Depositary Shares (ADSs). Cash will be paid in lieu of fractional **EVTCV** ADSs. **The merger became effective on Friday, May 2, 2008**

**Pending Contract Adjustments**
