### BEAR STEARNS COMPANIES INC (BSC) Pending Merger with JPMORGAN CHASE & CO (JPM)

On Thursday, May 29, 2008, the shareholders of Bear Stearns Companies Inc (BSC) will vote to approve the proposed merger with JPMorgan Chase & Co (JPM). If the merger is approved and consummated, each BSC share will be converted into the right to receive 0.21753 JPM Common Shares. Cash will be paid in lieu of fractional JPM shares. **The merger is anticipated to become effective by June 30, 2008.**

#### Pending Contract Adjustments

Pursuant to the by-laws of The Options Clearing Corporation ("OCC"), all Bear Stearns Companies Inc options will be adjusted as follows:
