Re: Parexel International Corp. (VBQ/PRXL) - 2 for 1 Stock Split

Parexel International Corp. (VBQ/PRXL) has declared a 2 for 1 stock split payable to share holders of record on Friday, February 22, 2008. Distribution date for the stock split will be Monday, March 3, 2008. **Ex-distribution date for the stock split will be Tuesday, March 4, 2008.** 

The Options Clearing Corporation (OCC), pursuant to OCC By-Laws, intends to issue on the distribution date (1) additional VBQ option contract for each option contract held. Further, on the ex-distribution date each VBQ series will have an adjusted exercise (strike) price equal to 1/2 of the exercise (strike) price for each VBQ series existing on the business day preceding the ex-distribution date. For example, beginning on Tuesday, March 4, 2008 an account holding (2) VBQ MAR 35 calls (VBQ CG) will hold (4) VBQ MAR 17 1/2 calls (VBQ CW). Customers should be advised that (1) contract in the adjusted VBQ series will still represent 100 shares of PRXL common shares.

## POSITION/EXERCISE LIMITS:

Position and exercise limits will change from 50,000 to 100,000 contracts until the expiration date of September 20, 2008

## **GOOD-TILL-CANCELLED (GTC) ORDERS:**

Customers should be advised that all Good-til-Cancelled (GTC) orders not on AUTOM must be cancelled and re-entered prior to the ex-distribution or effective date. GTC AUTOM orders will be deleted by PHLX Service Desk/AUTOM personnel.
