

SERIES ADJUSTMENT - 1758-08 October 10, 2008

CATALYST SEMICONDUCTOR INC (CATS) - MERGER - EFFECTIVE

On Wednesday, October 08, 2008, the shareholders of Catalyst Semiconductor Inc (CATS) approved the proposed merger with On Semiconductor Corp (ONNN). Pursuant to the merger terms, each CATS share will be converted into the right to receive 0.706 ONNN Common Shares. Cash will be paid in lieu of fractional ONNN shares. The merger became effective prior to opening of business on Friday, October 10, 2008.

Contract Adjustments:

Pursuant to the by-laws of The Options Clearing Corporation ("OCC"), all Catalyst Semiconductor Inc options will be adjusted as follows:

Adjustment Date: Effective with exercises of Friday, October 10, 2008 and thereafter.

Position and Exercise Limits:

Position and exercise limits will change from 2,500,000 to 36,125,000 shares until the expiration date of Saturday, March 21, 2009.

Adjusted Exercise Prices:

Effective with the opening of business on Friday, October 10, 2008, trading in CATS series will be on an adjusted basis. The strike price adjustments below are expected based on the current outstanding series. Any additional CATS series added prior to the effective date will also be adjusted in the manner outlined below.
