### CHINA NETCOM GROUP CORP LTD (CN) Pending Merger with CHINA UNICOM LTD (CHU)

On Tuesday, September 16, 2008, the shareholders of China Netcom Group Corp Ltd (CN) approved the proposed merger with China Unicom Ltd (CHU). Pursuant to the terms of the merger, each CN share will be converted into the right to receive 3.016 CHU American Depositary Shares. Cash will be paid in lieu of fractional CHU ADS's. **The merger is expected to become effective prior to the opening of business on October 15, 2008.**

#### Position and Exercise Limits:

Effective with the opening of business, after the date the merger is consummated, trading in CN will be on an adjusted basis. The strike price adjustments below are expected based on the current outstanding series.
