

SERIES ADJUSTMENT - 1673-08 September 22, 2008

NORTHWEST AIRLINES CORPORATION (NWA) Pending Merger with DELTA AIR LINES, INC. (DAL)

On Thursday, September 25, 2008, the shareholders of Northwest Airlines Corporation (NWA) will vote to approve the proposed merger with Delta Air Lines, Inc. (DAL). If the merger is approved and consummated, each NWA share will be converted into the right to receive 1.25 DAL Common Shares. Cash will be paid in lieu of fractional DAL shares. **The merger is expected to become effective on a date to be announced.**

Pending Contract Adjustments

Customers should be advised that all Good-til-Cancelled (GTC) orders not on AUTOM must be cancelled and re-entered prior to the ex-distribution or effective date. GTC AUTOM orders will be deleted by PHLX Service Desk/AUTOM personnel.

Position and Exercise Limits:

Position and exercise limits will change from 25,000,000 to 56,250,000 shares until the expiration date of Saturday, March 21, 2009.

Adjusted Exercise Prices:

Effective with the opening of business, after the date the merger is consummated, trading in NWA will be on an adjusted basis. The strike price adjustments below are expected based on the current outstanding series. **Any additional series added prior to the merger date will also be adjusted in the manner outlined below.**
