Subject: TD Banknorth, Inc. (BNK) Pending Merger With TD Bank Financial Group

On Wednesday, April 18, 2007, the shareholders of TD Banknorth, Inc. (BNK) will vote to approve the proposed merger with TD Bank Financial Group. Pursuant to the merger terms each BNK share will be converted into the right to receive \$32.33 cash. **The merger is anticipated to become effective on a date to be announced in the 2nd quarter of 2007.**

Pursuant to Options Clearing Corporation (OCC) By-Laws, all outstanding BNK options will be adjusted as follows:

EFFECTIVE DATE: Option changes are expected to become effective on a date to be announced
NEW DELIVERABLE: \$3,233.00 cash per contract (\$32.33 x 100)

Existing open interest in all BNK options will remain until options are exercised or expire. Since they are American style options, they are exercisable at the option of the holder.
