Subject: Altiris Inc. (ATRS/QJI) MERGER EFFECTIVE

On Wednesday, April 4, 2007, the shareholders of Altiris Inc. (ATRS) voted to approve the proposed merger with Symantec Corp. (SYMC). Pursuant to the merger terms each ATRS share will be converted into the right to receive \$33.00. **The merger became effective on Thursday, April 5, 2007.**

Pursuant to Options Clearing Corporation (OCC) By-Laws, all outstanding QJI options will be adjusted as follows:

EFFECTIVE DATE: Monday, April 9, 2007
NEW DELIVERABLE: \$3,300.00 cash per contract (\$33.00 x 100)

Existing open interest in all QJI options will remain until options are either exercised or expire. Since they are American style options, they are exercisable at the option of the holder.
