**Subject: \*\*UPDATE\*\* United Surgical Partners Int'l. (USPI/QPJ) Pending Merger**

On Wednesday, April 18, 2007, the shareholders of United Surgical Partners Int'l. (USPI) voted to approve the proposed merger with UNCN Holdings, Inc., a private equity fund affiliated with the private equity firm Welsh, Carson, Anderson & Stowe. Pursuant to the merger terms each USPI share will be converted into the right to receive \$31.05 cash. **The merger is anticipated to become effective on Thursday, April 19, 2007.**

Pursuant to Options Clearing Corporation (OCC) By-Laws, all outstanding QPJ options will be adjusted as follows:

**EFFECTIVE DATE: Option changes are expected to become effective on Friday, April 20, 2007**  
**NEW DELIVERABLE: \$3,105.00 cash per contract (\$31.05 x 100)**

**Existing open interest in all QPJ options will remain until options are exercised or expire. Since they are American style options, they are exercisable at the option of the holder.**
