RE: WITHDRAWAL OF APPROVAL OF CERTAIN
UNDERLYING SECURITIES AS OPTION CLASSES

Pursuant to the Exchange Rule 1010, The Philadelphia Stock Exchange, Inc. (Exchange) has determined that the common stock of Agere Systems, Inc. (AGR), Altiris Inc. (ATRS/QJI), Caremark Rx, Inc. (CMX), Carreker Corporation (CANI/CDU), ElkCorp (ELK), Inhibitex, Inc. (INHX/NEQ), Integrated Alarm Systems Group, Inc. (IASG/IQK), Molecular Devices Corporation (MDCC/MCQ), New River Pharmaceuticals, Inc. (NRPH/QNC), Phelps Dodge Corp (PD), ProQuest Company (PQES/PQE), Quantum Fuel Systems Technologies (QTWW/TQD), SafeNet, Inc. (SFNT/UII), Sea Containers Ltd – Class A (SCR/A / QRF) SpectraLink Corp (SLNK/SXU), TD Banknorth, Inc. (BNK), The Mills Corporation (MLS), and United Surgical Partners Int'l. (USPI/QPJ) no longer meet the current requirements necessary to maintain approval as securities underlying listed options.

Therefore, the Exchange will not open any additional (AGR), (QJI), (CMX), (CDU), (ELK), (NEQ), (IQK), (MCQ), (QNC), (PD), (PQE), (TQD), (UII), (QRF), (SXU), (BNK), (MLS) and (RDA) option series.

Further, the Exchange requests that member organizations advise their customers of this announcement before entering option orders for customer accounts in the above noted issues.
