Re: Domino's Pizza, Inc. (DPZ) - Special Cash Dividend

Domino's Pizza, Inc. (DPZ) has declared a special cash dividend of \$13.50 payable to share holders of record on Friday, April 27, 2007. Distribution date for the special cash dividend will be Friday, May 4, 2007. **Ex-distribution date for the special cash dividend will be Monday, May 7, 2007.**

On the ex-distribution date, the Options Clearing Corporation (OCC), pursuant to OCC By-Laws, shall adjust each DPZ series by subtracting the cash dividend from the strike prices and rounding the result to the nearest eighth of a dollar.

POSITION/EXERCISE LIMITS:

Position and exercise limits will not change and premiums and strike-price amounts for the adjusted DPZ will continue to be calculated on the basis of a multiplier of 100.

GOOD-TILL-CANCELLED (GTC) ORDERS:

Customers should be advised that all Good-til-Cancelled (GTC) orders not on AUTOM must be cancelled and re-entered prior to the ex-distribution or effective date. GTC AUTOM orders will be deleted by PHLX Service Desk/AUTOM personnel.
