Subject: TXU Corporation (TXU) Pending Merger With Texas Energy Future Holdings Limited

On Friday, September 7, 2007, the shareholders of TXU Corporation (TXU) will vote to approve the proposed merger with Texas Energy Future Holdings Limited. Pursuant to the merger terms each TXU share will be converted into the right to receive \$69.25 cash. **The merger is anticipated to become effective in the fourth quarter of 2007.**

Pursuant to Options Clearing Corporation (OCC) By-Laws, all outstanding TXU options will be adjusted as follows:

EFFECTIVE DATE: Option changes are expected to become effective on a date to be announced
NEW DELIVERABLE: \$6,925.00 cash per contract (\$69.25 x 100)

Existing open interest in all TXU options will remain until options are exercised or expire. Since they are American style options, they are exercisable at the option of the holder.
