Re: **** UPDATE ** Doral Financial Corp. (DRL) - 1 for 20 Reverse Stock Split**

Doral Financial Corp. (DRL) has declared a 1 for 20 reverse stock split payable to shareholders of record on a date to be announced. As a result of the reverse stock split, each DRL Common Share will be converted into the right to receive 0.05 (New) Doral Financial Corp. Common Shares. Distribution date for the stock split will be on a date to be announced. **Ex-distribution date for the stock split is Monday, August 20, 2007.**

EFFECTIVE DATE: Monday, August 20, 2007

SYMBOL: **DRL becomes DQY**
OVL becomes OWU

POSITION LIMITS: No change

STRIKE PRICES No change
