Subject: Chaparral Steel Company (CHAP/ZHQ) Pending Merger With Gerdau Ameristeel Corporation (GNA)

On Wednesday, September 12, 2007, the shareholders of Chaparral Steel Company (CHAP) will vote to approve the proposed merger with Gerdau Ameristeel Corporation (GNA). Pursuant to the merger terms each CHAP share will be converted into the right to receive \$86.00 cash. **The merger is anticipated to become effective on a date to be announced in late 2007.**

Pursuant to Options Clearing Corporation (OCC) By-Laws, all outstanding ZHQ options will be adjusted as follows:

EFFECTIVE DATE: Option changes are expected to become effective on a date to be announced
NEW DELIVERABLE: \$8,600.00 cash per contract (\$86.00 x 100)

Existing open interest in all ZHQ options will remain until options are exercised or expire. Since they are American style options, they are exercisable at the option of the holder.
