Subject: Genesco, Inc. (GCO) Pending Merger With The Finish Line, Inc.

On Monday, September 17, 2007, the shareholders of Genesco, Inc. (GCO) will vote to approve the proposed merger with The Finish Line, Inc. Pursuant to the merger terms each GCO share will be converted into the right to receive \$54.50 cash. **The merger is anticipated to become effective by the end of October 2007.**

Pursuant to Options Clearing Corporation (OCC) By-Laws, all outstanding GCO options will be adjusted as follows:

EFFECTIVE DATE: Option changes are expected to become effective on a date to be announced
NEW DELIVERABLE: \$5,450.00 cash per contract (\$54.50 x 100)

Existing open interest in all GCO options will remain until options are exercised or expire. Since they are American style options, they are exercisable at the option of the holder.
