Subject: EDO Corporation (EDO) Pending Merger UPDATE

On Tuesday, December 18, 2007, the shareholders of EDO Corporation (EDO) will vote to approve the proposed merger with ITT Corporation. Pursuant to the merger terms each EDO share will be converted into the right to receive \$56.00 cash. **The merger is anticipated to become effective on Thursday, December 20, 2007.**

Pursuant to Options Clearing Corporation (OCC) By-Laws, all outstanding EDO options will be adjusted as follows:

EFFECTIVE DATE: Option changes are expected to become effective on Friday, December 21, 2007
NEW DELIVERABLE: \$5,600.00 cash per contract (\$56.00 x 100)

Existing open interest in all EDO options will remain until options are exercised or expire. Since they are American style options, they are exercisable at the option of the holder.
