RE: WITHDRAWAL OF APPROVAL OF CERTAIN
UNDERLYING SECURITIES AS OPTION CLASSES

Pursuant to the Exchange Rule 1010, The Philadelphia Stock Exchange, Inc. (Exchange) has determined that the common stocks of ALLTEL Corporation (AT), Applebee's International, Inc. (APPB/ AQB), Dow Jones & Company (DJ), EDO Corporation (EDO), Global Santa Fe International Corporation (GSF), Hapoalim American Israeli Index (HAI), Horizon Offshore, Inc. (HOFF/ HNQ), InPhonic, Inc. (INPC/ QIO), SIG Coal Producers Index (SCP), SIG Steel Producers Index (STQ), Targeted Genetics Corporation (TGEN/ EKQ), Volvo AB (VOLVY/ VQY), Wheeling-Pittsburgh Corporation (WPSC/ UFL) no longer meet the current requirements necessary to maintain approval as securities underlying listed options.

Therefore, the Exchange will not open any additional (AT), (VTB), (WJH), (AQB), (DJ), (EDO), (ZXV), (ZWG), (GSF), (HAI), (HNQ), (QIO), (SCP), (CFV), (STQ), (EKQ), (SSV), (TYO), (VQY), and (UFL) option series.

Further, the Exchange requests that member organizations advise their customers of this announcement before entering option orders for customer accounts in the above noted issues.
