Re: Synovus Financial Corporation (SNV) - Stock Distribution ***REVISED 2009 ADJUSTED LEAP SYMBOL***

Synovus Financial Corporation (SNV) has declared a distribution of Common Stock of Total System Services, Inc. (TSS) to SNV shareholders of record, December 18, 2007. The distribution will be .484 shares of Total System Services, Inc. (TSS) per share of Synovus Financial Corporation held. Distribution date will be Monday, December 31, 2007. **The ex-distribution date is Wednesday, January 2, 2008.**

Accordingly, pursuant to OCC By-Laws, all SNV options on the ex-distribution date must be adjusted as follows:

Adjustment Date: Effective Wednesday, January 2, 2008.
 Symbol(s): SNV/OHA/YNC becomes SOZ/VZR/YOC
 Strike Price: Unchanged
 Multiplier: 100 (e.g., Premium of 1.00 = \$100)
 New Deliverable: 1) 100 Shares of Synovus Financial Corporation (SNV)
 2) 48 Shares of Total System Services, Inc. (TSS)
 3) Cash in lieu of .40 fractional TSS shares
