Subject: Conor Medsystems, Inc. (CONR/QAP) Merger With Johnson & Johnson (JNJ) **EFFECTIVE**

On Wednesday, January 31, 2007, the shareholders of Conor Medsystems, Inc. (CONR) voted to approve the proposed merger with Johnson & Johnson (JNJ). Pursuant to the merger terms each CONR share will be converted into the right to receive \$33.50 cash. **The merger became effective on Thursday, February 1, 2007.**

Pursuant to Options Clearing Corporation (OCC) By-Laws, all outstanding QAP options will be adjusted as follows:

EFFECTIVE DATE: Friday, February 2, 2007
NEW DELIVERABLE: \$3,350.00 cash per contract (\$33.50 x 100)

Existing open interest in all QAP options will remain until options are either exercised or expire. Since they are American style options, they are exercisable at the option of the holder.
