Subject: **UPDATE The Yankee Candle Company (YCC) Pending Merger**

On Tuesday, January 23, 2007, the shareholders of The Yankee Candle Company (YCC) voted to approve the proposed merger with Madison Dearborn Partners, LLC (MDP). Pursuant to the merger terms each YCC share will be converted into the right to receive \$34.75 cash. **The merger is anticipated to become effective on Tuesday, February 6, 2007.**

Pursuant to Options Clearing Corporation (OCC) By-Laws, all outstanding YCC options will be adjusted as follows:

EFFECTIVE DATE: Option changes are expected to become effective on Wednesday, February 7, 2007
NEW DELIVERABLE: \$3,475.00 cash per contract (\$34.75 x 100)

Existing open interest in all YCC options will remain until options are either exercised or expire. Since they are American style options, they are exercisable at the option of the holder.
