Subject: **UPDATE Equity Office Properties Trust (EOP) Pending Merger**

On Monday, February 5, 2007, the shareholders of Equity Office Properties Trust (EOP) voted to approve the proposed merger with The Blackstone Group. Pursuant to the merger terms each EOP share will be converted into the right to receive **\$55.50 cash (not \$54.00)**. **The merger is anticipated to become effective on Friday, February 9, 2007.**

Pursuant to Options Clearing Corporation (OCC) By-Laws, all outstanding EOP options will be adjusted as follows:

EFFECTIVE DATE: Option changes are expected to become effective on a date to be announced
NEW DELIVERABLE: **\$5,550.00 cash per contract (\$55.50 x 100)**

Existing open interest in all EOP options will remain until options are either exercised or expire. Since they are American style options, they are exercisable at the option of the holder.
