On Thursday, February 22, 2007, the shareholders of DocuCorp International, Inc (DOCC) will vote to approve the proposed merger with Skywire Software, LLC. Pursuant to the merger terms each DOCC share will be converted into the right to receive \$10.00 cash. **The merger is anticipated to become effective shortly following the special meeting of shareholders.**

Pursuant to Options Clearing Corporation (OCC) By-Laws, all outstanding QRI options will be adjusted as follows:

**EFFECTIVE DATE: Option changes are expected to become effective on a date to be announced**  
**NEW DELIVERABLE: \$1,000.00 cash per contract (\$10.00 x 100)**

**Existing open interest in all QRI options will remain until options are exercised or expire. Since they are American style options, they are exercisable at the option of the holder.**
