Subject: ARAMARK Corporation (RMK) Pending Merger With RMK Acquisition Corporation UPDATE

On Wednesday, December 20, 2006, the shareholders of ARAMARK Corporation (RMK) voted to approve the proposed merger by a consortium of private equity funds sponsored by GS Capital Partners V Fund, L.P., J.P.Morgan Partners, L.P., CCMP Capital Investors II, L.P., et al. Pursuant to the merger terms each RMK share will be converted into the right to receive \$33.80 cash. **The merger is anticipated to become effective on Friday, January 26, 2007.**

Pursuant to Options Clearing Corporation (OCC) By-Laws, all outstanding RMK options will be adjusted as follows:

EFFECTIVE DATE: Option changes are expected to become effective on Monday, January 29, 2007
NEW DELIVERABLE: \$3,380.00 cash per contract (\$33.80 x 100)

Existing open interest in all RMK options will remain until options are either exercised or expire. Since they are American style options, they are exercisable at the option of the holder.
