**Subject: McData Corporation - Class A (MCDTA/MQG) & McData Corporation - Class B (MCDT/DXZ)  
Pending Merger With Brocade Communications Systems, Inc. (BRCD) \*\* UPDATE\*\***

On Thursday, January 25, 2007, the shareholders of McData Corporation - Class A (MCDTA) and McData Corporation - Class B (MCDT) will vote to approve the proposed merger with Brocade Communications Systems, Inc. (BRCD). Pursuant to the merger terms each MCDTA and MCDT common share will be converted into the right to receive .75 BRCD common shares. Cash will be paid in lieu of fractional BRCD shares. **The merger is anticipated to become effective on Monday, January 29, 2007.**

**EFFECTIVE DATE:** Option changes are expected to become effective on a date to be announced

**SYMBOL(s):** 1) MQG/YGV/OVK becomes MZV/YXL/ZDC, respectively  
2) DXZ/YTO/VGF becomes AWU/LMM/ZME, respectively

**STRIKE PRICE:** No Change

**POS/EXERCISE LIMIT:** 700,000 contracts until January 2009 expiration; where the limits revert to 250,000 contracts

**MULTIPLIER:** 100\*(eg., Premium of 1.00 = \$100)

**NEW DELIVERABLE:** 1) 75 BRCD common shares.  
2) Cash in lieu of fractional BRCD shares
