Subject: Rita Medical Systems, Inc. (RITA/RQE) Merger With AngioDynamics, Inc. (ANGO)**EFFECTIVE**

On Monday, January 29, 2007, the shareholders of Rita Medical Systems, Inc. (RITA) voted to approve the proposed merger with AngioDynamics, Inc. (ANGO). Pursuant to the merger terms each RITA share will be converted into the right to receive 0.1722 ANGO common shares plus \$0.5150 cash. Cash will be paid in lieu of fractional shares. **The merger became effective on Monday, January 29, 2007.**
