Subject: CBOT Holdings, Inc. (BOT) Merger **EFFECTIVE**

On Monday, July 9, 2007, the shareholders of CBOT Holdings, Inc. (BOT) approved the proposed merger with Chicago Mercantile Exchange Holdings Inc (CME). Pursuant to the merger terms each BOT share will be converted into the right to receive 0.375 CME common shares. Cash will be paid in lieu of fractional shares. **The merger became effective on Thursday, July 12, 2007.**

NOTE: Chicago Mercantile Exchange Holdings Inc. (CME) will change its name & CUSIP number, but the option/ticker symbol will remain unchanged.

EFFECTIVE DATE: Friday, July 13, 2007
SYMBOL(s): BOT becomes BOD
STRIKE PRICE: No Change
POS/EXERCISE LIMIT: 500,000 contracts until December 2007 expiration; where the limits revert to 250,000 contracts
MULTIPLIER: 100*(eg., Premium of 1.00 = \$100)
NEW DELIVERABLE: 1) 37 CME common shares.
 2) Cash in lieu of 0.5 fractional CME shares.
