Re: **Kindred Healthcare, Inc. (KND) - REVISED Final Distribution Ratio**

Kindred Healthcare, Inc. (KND) has declared a distribution of Common Stock of PharMerica Corporation (PMC) to KND shareholders of record, July 20, 2007. Distribution will be Tuesday, July 31, 2007. **Ex-distribution is August 1, 2007.** The distribution will be **0.3660241 shares (not 0.3660254)** of PharMerica Corporation per share of Kindred Healthcare, Inc. Cash will be paid in lieu of fractional shares of PharMerica Corporation.

Accordingly, pursuant to OCC By-Laws, all KND options on the ex-distribution date must be adjusted as follows:

**Adjustment Date:** Effective Wednesday, August 1, 2007.  
**Symbol(s):** KND/OXK/WKC becomes KNS/KMV/XUM  
**Strike Price:** Unchanged  
**Multiplier:** 100 (e.g., Premium of 1.00 = \$100)  
**New Deliverable:**

- 1) **100 Shares of Kindred Healthcare, Inc. (KND)**
- 2) **36 Shares of PharMerica Corporation (PMC)**
- 3) **Cash in lieu of 0.60241 (not 0.60254) fractional PMC shares**
