Subject: Spirit Finance Corp (SFC) Pending Merger

On Monday, July 2, 2007, the shareholders of Spirit Finance Corp (SFC) voted to approve the proposed merger with Redford Holdco LLC. Pursuant to the merger terms each SFC share will be converted into the right to receive \$14.50 cash. **The merger is anticipated to become effective on Tuesday, July 31, 2007.**

Pursuant to Options Clearing Corporation (OCC) By-Laws, all outstanding SFC options will be adjusted as follows:

EFFECTIVE DATE: Option changes are expected to become effective on Wednesday, August 1, 2007
NEW DELIVERABLE: \$1,450.00 cash per contract (\$14.50 x 100)

Existing open interest in all SFC options will remain until options are exercised or expire. Since they are American style options, they are exercisable at the option of the holder.
