**Re: AmerisourceBergen Corp. (ABC) - Stock Distribution \*\*Symbol Change\*\***

AmerisourceBergen Corp. (ABC) has declared a distribution of Common Stock of PharMedica Corporation (PMC) to ABC shareholders of record, July 20, 2007. Distribution will be Tuesday, July 31, 2007. **Ex-distribution is August 1, 2007.** The distribution will be **0.0833752 shares** of PharMedica Corporation per share of AmerisourceBergen Corp. Cash will be paid in lieu of fractional shares of PharMedica Corporation.

Accordingly, pursuant to OCC By-Laws, all ABC options on the ex-distribution date must be adjusted as follows:

**Adjustment Date:** Effective Wednesday, August 1, 2007.  
**Symbol(s):** ABC/OYY/YPP becomes AAK/KGL/ZJV  
**Strike Price:** Unchanged  
**Multiplier:** 100 (e.g., Premium of 1.00 = \$100)  
**New Deliverable:** 1) 100 Shares of AmerisourceBergen Corp. (ABC)  
 2) 8 Shares of PharMedica Corporation (PMC)  
 3) Cash in lieu of 0.33752 (not 0.31850) fractional PMC shares
