Subject: Paxar Corporation (PXR) Merger **EFFECTIVE**

On Thursday, June 14, 2007, the shareholders of Paxar Corporation (PXR) voted to approve the proposed merger with Avery Dennison Corporation. Pursuant to the merger terms each PXR share will be converted into the right to receive \$30.50 cash. The merger became effective on Friday, June 15, 2007.

Pursuant to Options Clearing Corporation (OCC) By-Laws, all outstanding PXR options will be adjusted as follows:

EFFECTIVE DATE: Monday, June 18, 2007
NEW DELIVERABLE: \$3,050.00 cash per contract (\$30.50 x 100)

Existing open interest in all PXR options will remain until options are exercised or expire. Since they are American style options, they are exercisable at the option of the holder.
