Subject: Lear Corporation (LEA) Pending Merger With American Real Estate Partners, L.P.

On June 27, 2007, the shareholders of Lear Corporation (LEA) will vote to approve the proposed merger with American Real Estate Partners, L.P. Pursuant to the merger terms each LEA share will be converted into the right to receive \$36.00 cash. **The merger is anticipated to become effective on a date to be announced in the 2nd quarter of 2007.**

Pursuant to Options Clearing Corporation (OCC) By-Laws, all outstanding LEA options will be adjusted as follows:

EFFECTIVE DATE: Option changes are expected to become effective on a date to be announced
NEW DELIVERABLE: \$3,600.00 cash per contract (\$36.00 x 100)

Existing open interest in all LEA options will remain until options are exercised or expire. Since they are American style options, they are exercisable at the option of the holder.
