Subject: Domtar, Inc. (DTC) - (Changes Name, Option/Ticker Symbol & Cusip Number)

On February 26, 2007, shareholders of Domtar, Inc. (DTC) voted on a Plan of Arrangement with Weyerhaeuser Company's fine paper business. Pursuant to the terms of the Arrangement, each existing DTC Common Share will be converted into the right to receive one ("New") Domtar Corporation (UFS) Common Share. **The Plan of Arrangement will become effective on Tuesday, March 6, 2007.**

The Philadelphia Stock Exchange (PHLX) has been advised that Domtar, Inc. (DTC) Common Stock will have the following changes made, on the date shown below:
