Subject: Commonwealth Telephone Enterprises, Inc. (CTCO/QOK) Merger **EFFECTIVE**

On Thursday, January 25, 2007, the shareholders of Commonwealth Telephone Enterprises, Inc. (CTCO) voted to approve the proposed merger with Citizens Communications Company (CZN). Pursuant to the merger terms each CTCO share will be converted into the right to receive 0.768 CZN common shares plus \$31.31 cash. Cash will be paid in lieu of fractional CZN shares. **The merger became effective on Thursday, March 8, 2007.**
