Subject: Phelps Dodge Corp. (PD) Merger **EFFECTIVE**

On Wednesday, March 14, 2007, the shareholders of Phelps Dodge Corp. (PD) voted to approve the proposed merger with Freeport McMoran Copper & Gold Inc. (FCX). Pursuant to the merger terms each PD share will be converted into the right to receive 0.67 FCX common shares plus \$88.00 cash. **The merger became effective on Monday, March 19, 2007**

**STRIKE PRICE:** No Change

**POS/EXERCISE LIMIT:** 750,000 contracts until June 2007 expiration where the limits revert to 450,000 contracts  
The limits will further reduce to 250,000 contracts following the January 2009 expiration.

**MULTIPLIER:** 100\*(eg., Premium of 1.00 = \$100)

**NEW DELIVERABLE:** **1) 67 FCX common shares.**  
**2) \$8,800.00 cash (\$88.00 x 100)**
