 Re: **Altria Group Inc. (MO) - Stock Distribution**

Altria Group Inc. (MO) has declared a distribution of Class A Common Stock of Kraft Foods, Inc. (KFT) to MO shareholders of record, March 16, 2007. Distribution will be Friday, March 30, 2007. **Ex-distribution is April 2, 2007.** The distribution will be .692024 shares of Kraft Foods, Inc. per share of Altria Group Inc. Cash will be paid in lieu of fractional KFT shares.

Accordingly, pursuant to OCC By-Laws, all MO options on the ex-distribution date must be adjusted as follows:

Adjustment Date: **Effective Monday, April 2, 2007.**  
 Symbol(s): **MO/WRR/VPM becomes MOZ/LLM/ZKM**  
 Strike Price: Unchanged  
 Multiplier: 100 (e.g., Premium of 1.00 = \$100)  
 New Deliverable: **1) 100 Shares of Altria Group Inc. (MO)**  
**2) 69 Shares of Kraft Foods, Inc. (KFT)**  
**3) Cash in lieu of .2024 fractional shares of Kraft Foods, Inc.**
