Subject: Novelis, Inc. (NVL) MERGER EFFECTIVE

On Thursday, May 10, 2007, the shareholders of Novelis, Inc. (NVL) voted to approve the proposed merger with Hindalco Industries Limited. Pursuant to the merger terms each NVL share will be converted into the right to receive \$44.93 cash. **The merger became effective before the opening on Tuesday, May 15, 2007.**

Pursuant to Options Clearing Corporation (OCC) By-Laws, all outstanding NVL options will be adjusted as follows:

EFFECTIVE DATE: Tuesday, May 15, 2007
NEW DELIVERABLE: \$4,493.00 cash per contract (\$44.93 x 100)

Existing open interest in all NVL options will remain until options are exercised or expire. Since they are American style options, they are exercisable at the option of the holder.
