On Tuesday, May 1, 2007, the shareholders of Witness Systems, Inc. (WITS) voted to approve the proposed merger with Verint Systems, Inc. (VRNT). Pursuant to the merger terms each WITS share will be converted into the right to receive \$27.50 cash. **The merger became effective on Tuesday, May 29, 2007.**

Pursuant to Options Clearing Corporation (OCC) By-Laws, all outstanding UPJ options will be adjusted as follows:

**EFFECTIVE DATE: Wednesday, May 30, 2007**  
**NEW DELIVERABLE: \$2,750.00 cash per contract (\$27.50 x 100)**

**Existing open interest in all UPJ options will remain until options are exercised or expire. Since they are American style options, they are exercisable at the option of the holder.**
