 Subject: **GlobalSantaFe Corporation (GSF) Pending Merger With Transocean Inc. (RIG)**

On Friday, November 9, 2007, the shareholders of GlobalSantaFe Corporation (GSF) voted to approve the proposed merger with Transocean Inc. (RIG). Pursuant to the merger terms each GSF share will be converted into the right to receive 0.4757 (New) Transocean Inc. (RIG) Ordinary Shares plus \$22.46 cash. Cash will be paid in lieu of fractional shares. **The merger is anticipated to become effective prior to the opening of business on Tuesday, November 27, 2007**
