Re: Oil Service HOLDRs (OIH/ODL) - Cash Distribution

On November 27, 2007, the merger between Transocean Inc. (RIG) & GlobalSantaFe Corp. (GSF), both components of TTH, is expected to become effective. As a result, the merger consideration for both issues will be distributed to OIH shareholders. The distribution ratio is \$10.431785 per each 100 OIH round lot to shareholders of record, November 30, 2007. The distribution date has yet to be determined. **The AMEX has set the ex-distribution date as Wednesday, November 28, 2007.**
