Subject: Dobson Communications Corporation (DCEL/QDM) Pending Merger With AT&T Inc.

The Board of Directors of Dobson Communications Corporation (DCEL) has voted to approve the proposed merger with AT&T Inc. Pursuant to the merger terms each DCEL share will be converted into the right to receive \$13.00 cash. **The merger will become effective on a date to be announced.**

Pursuant to Options Clearing Corporation (OCC) By-Laws, all outstanding QDM options will be adjusted as follows:

EFFECTIVE DATE: Option changes are expected to become effective on a date to be announced
NEW DELIVERABLE: \$1,300.00 cash per contract (\$13.00 x 100)

Existing open interest in all QDM options will remain until options are exercised or expire. Since they are American style options, they are exercisable at the option of the holder.
