Subject: Huntsman Corporation (HUN) Pending Merger With Hexion Specialty Chemicals, Inc.

On Tuesday, October 16, 2007, the shareholders of Huntsman Corporation (HUN) will vote to approve the proposed merger with Hexion Specialty Chemicals, Inc. Pursuant to the merger terms each HUN share will be converted into the right to receive \$28.00 cash, with the chance of an upward adjustment. **The merger will become effective on a date to be announced.**

Pursuant to Options Clearing Corporation (OCC) By-Laws, all outstanding HUN options will be adjusted as follows:

EFFECTIVE DATE: Option changes are expected to become effective on a date to be announced
NEW DELIVERABLE: \$2,800.00 cash per contract (\$28.00 x 100), with the chance of an upward adjustment

Existing open interest in all HUN options will remain until options are exercised or expire. Since they are American style options, they are exercisable at the option of the holder.
