Subject: Biomet, Inc. (BMET/BIQ) Merger **EFFECTIVE**

The Tender Offer by LVB Acquisition, Inc., an entity sponsored by The Blackstone Group, Goldman Sachs & Co., Texas Pacific Group & Kohlberg Kravis & Roberts, to purchase all the outstanding shares of Biomet, Inc. (BMET) for \$46.00 per common share expired on July 11, 2007. After the expiration of the tender offer, there will be a short-form merger. **The merger became effective on Tuesday, September 25, 2007.**

Pursuant to Options Clearing Corporation (OCC) By-Laws, all outstanding BIQ options will be adjusted as follows:

EFFECTIVE DATE: Wednesday, September 26, 2007
NEW DELIVERABLE: \$4,600.00 cash per contract (\$46.00 x 100)

Existing open interest in all BIQ options will remain until options are exercised or expire. Since they are American style options, they are exercisable at the option of the holder.
